5. Achievement of the Expected Results

The main task was to provide recommendations for improvement of education standards for qualification for programmes in the priority areas (incl. legislative arrangements) with a view to describing achievements based on competences and skills, considering the AzQF. During this mission the latest version of State standard of higher education of Bachelor level (Specialty cipher and name: 050655 – Information technologies) was improved by major changes as follows:

- 1. State's standard's document was reviewed and major corrections were made including:
 - a. the updated list of compulsory subjects was provided (see Annex 1);
 - b. the list of elective subjects was provided (see Annex 1);
 - c. the list of general and professional competencies was improved (see Annex 1);
 - d. the list of learning outcomes was created (see Annex 1);
 - e. subjects and general competencies matrix was proposed (see Annex 1);
 - f. subjects and professional competencies relation matrix was proposed (see Annex 1);
 - g. Study programme content of two types was proposed

Planned actions were achieved.

Unexpected results were not identified during the mission.

7. Issues Left Open After the Mission

8. Recommendations and conclusions (including recommendation for future missions)

Update the latest version of State standard of higher education of bachelor level (Specialty cipher and name: 050655 – Information technologies) by the changes listed below:

8.1 During Monday's 23rd of September 2019 meeting where stated that the general competencies should be the same for all State standards of higher education of bachelor level regardless of the specifics of the field of study. So general competencies of this particular standard should be unified with general competencies listed in other State standards.

8.2 I suggest decrease the number of ECTS for MPS - B01 Mathematics from 16 to 10, because 10 ECTS is enough for theoretical background for Informational technologies study program.

8.4 I suggest Compulsory teach "User requirements Engineering" course instead "Physics", because it covers one of the essential stages of software development lifecycle like design, development and quality assurance stages.

8.5 Learning outcomes are presented in very detailed manner (that's good), but it is hard to relate them with particular subjects in relations matrix. I suggest combine them to at most 10 units for every module (Humanities, Professional subjects and Internship). It will help to understand the relations among outcomes and subjects more easily.

8.6. I propose two different types of study programmes: modules based as well as subjects based (see Annex 1)

8.7 I Suggest include Bachelor Project as compulsory 15 credits subject including final project defense procedure.

The mission well organized, all the planned activities were performed according the schedule. Major of necessary documents were provided in advance. I had the opportunity to visit Azerbaijan Technical University (on Wednesday) and Azerbaijan State Oil and Industry University (Thursday) these visits helped to understand the infrastructure and resources necessary for implementation of State standard of higher education more clearly.
